**Attention:**

Carefully read all instructions and review the images before installing this product.  
**Do not** attach anything to the mount face plate until after installing the mount to the dashboard. Doing so makes it more difficult to install the mount to the dash and non-refundable since you have screwed into it.



1. Press the thin end of the enclosed gap opener into the gap between the center console information screen panel and panel frame surrounding it, to widen the gap.

Peel off the cover of adhesive tape on the ProClip.



2. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top.

Press the angled edge on the lower part of the ProClip into the gap next to the gap opener.



3. Press firmly forward on the ProClip so it flexes forward and the angled edge hooks around the panel frame edge under the padded part of the dashboard.

Pull out the gap opener.

Note: The adhesive tape does not leave any marks or damage the dashboard, and is easy to remove.



4. The ProClip Mount is in place.

## Returns
