1. Clean the area where the ProClip will attach. Remove the cover from the adhesive tape on the ProClip. Note: The adhesive tape does not leave any marks or damage the dashboard, and is easy to remove.

Press the thin angled edge on the forward part of the ProClip into the seam between the top part of the dash and the inner part of the defroster vent.



2. With your finger behind the face plate of the ProClip, flex the thick angled edge on the back side of the ProClip out and around the dash, then insert the edge into the top of the right center vent opening.



3. Press down on the face plate of the ProClip to make sure the tape adheres to the dash



4. The ProClip Mount is in place.
