Attention:

Carefully read all instructions and review the images before installing this product.

Do not attach anything to the mount face plate until after installing the mount to the dashboard. Doing so makes it more difficult to install the mount to the dash and non-refundable since you have screwed into it.



1. Press the thin end of the enclosed gap openers into the gap between the air vent frame and the padded part of the dashboard, to widen the gap.



2. Peel off the cover of adhesive tape on the ProClip. Note: The adhesive tape does not leave any marks or damage the dashboard, and is easy to remove. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top.

Press the angled edge on the right side of the ProClip into the gap between the gap openers. Press until you see or hear/feel it clicks into place. Pull out the gap openers.



3. Press the thin end of one gap opener into the gap between the air vent frame and the frame surrounding the panel, to widen the gap. Press the thin end on the left side of the ProClip into the gap below the gap opener. Pull out the gap opener.



4. The ProClip Mount is in place.

Returns
