#### Attention:

Carefully read all instructions and review the images before installing this product.

**Do not** attach anything to the mount face plate until after installing the mount to the dashboard. Doing so makes it more difficult to install the mount to the dash and non-refundable since you have screwed into it.

Note: This ProClip can also be attached on the left side of the break handle and on the left side of the steering wheel or you can have one ProClip attached for each location. The same instructions apply for all placements as shown below.



1. Peel off the cover of the adhesive tape on the ProClip. Place the angled edges on the upper part of the ProClip into the groove in the dashboard.



2. Place your index finger behind the lower part of the ProClip and pull down so the angled edge snaps over the dashboard edge.



3. Press firmly forward on the lower part of the ProClip so the angled edge snaps into the gap between the center panel and the dashboard edge.



4. The ProClip Mount is in place.

### Returns

All returns must be made within thirty (30) days of the delivery date and include proof of purchase, a copy of your original order, or invoice.
