#### Attention:

**Do not** attach anything to the mount face plate until after installing the mount to the dashboard. Doing so makes it more difficult to install the mount to the dash and non-refundable since you have screwed into it.

ONLY for the Wing Dash style.





1. Remove the screw above the air vent. Peel off the cover of adhesive tape on the ProClip. Note: The adhesive tape does not leave any marks or damage the dashboard, and is easy to remove. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top. Use your left hand to pull the top part of the panel frame towards you (Approx. 1/2 inch.) Then hook the angled edge on the right side of the ProClip around the panel frame edge.



2. Align the upper hole in the ProClip over the screw hole in the dash. Push the panel frame back into place and screw the screw just a few threads into the screw hole.



3. Using your left hand again, pull the panel frame slightly towards you. Then push forward on the left side of the ProClip so the angled edge hooks around the panel frame edge. Push the panel frame back into place and secure the frame and the ProClip by tightening the screw.



4. The ProClip Mount is in place.

### Returns
