1. Installing the Mount:

Gently clean the area where the ProClip will attach. Remove the cover from the adhesive tape on the ProClip.

Press the thin angled edge on the forward part of the ProClip into the seam between the top part of the dash and the inner part of the defroster vent.



2. Installing the Mount:

With your fingers behind the face plate pull the ProClip so it flexes towards you. Hook the thick angled edge on the back side of the ProClip around the dash edge and into the top of the air vent opening.



3. **Installing the Mount:** Apply pressure on the lower part of the ProClip face plate to make sure the tape adheres to the dash trim.



4. The ProClip Mount is in place.
