Attention:

Do not attach anything to the mount face plate until after installing the mount to the dashboard. Doing so makes it more difficult to install the mount to the dash and non-refundable since you have screwed into it.

Also, our installation instructions are often printed prior to the last year of a ProClip mount listing. The year listing we show on our web site should be the most accurate listing.



1. Clean the area where the ProClip will attach. insert the gap opener into the seam between the left frame around the left center vent and the padded part of the dash, to widen the gap. (See photo.)

The adhesive tape cover must be removed.



2. Place the ProClip in your hand so the ProClip label (sticker) is on the left.

Place the right edge of the ProClip, with the tape, onto the left side of the vent frame.



3. Press forward on the left side of the face plate to flex the left attaching edge into the seam above the gap opener.

Pull out the gap opener.



4. The ProClip is in place.

NOTE - The adhesive tape cover should be removed. The tape does not leave any marks or damage the dashboard, and is easy to remove.

Returns
