Attention:

Carefully read all instructions and review the images before installing this product.

Do not attach anything to the mount face plate until after installing the mount to the dashboard. Doing so makes it more difficult to install the mount to the dash and non-refundable since you have screwed into it.

Also, our installation instructions are often printed prior to the last year of a ProClip mount listing. The year listing we show on our web site should be the most accurate listing.



1. Clean the area where the ProClip will attach. Remove the tape covering from any tape on the mount. The lower edge of Part 1 of the mount should be inserted into the seam between the horizontal and vertical glossy hard plastic trim panels in the dash to the left of the information screen. See photo illustration.



2. Once part 1 of the mount is in place, insert the thin right edge of part 2 of the mount (the face plate part) into the seam between the silver trim on the left side of the display screen and the back panel of the display. See photo.



3. Align the holes in part 2 with the holes in part 1.



4. Screw the two parts together. Screw the screws tight but be careful not to over tighten the screws.

Returns

All returns must be made within thirty (30) days of the delivery date and include proof of purchase, a copy of your original order, or invoice. No products shipped hereunder may be returned without ProClip USA's prior approval. In order to return a product, the buyer must obtain an RMA number (Return Merchandise Authorization Number).
