Attention:

Carefully read all instructions and review the images before installing this product.

**Do not** attach anything to the mount face plate until after installing the mount to the dashboard. Doing so makes it more difficult to install the mount to the dash and non-refundable since you have screwed into it.

**Also**, our installation instructions are often printed prior to the last year of a ProClip mount listing. The year listing we show on our web site should be the most accurate listing.



1. Clean the area where the ProClip will attach. The adhesive tape cover must be removed.

Insert the gap opener into the seam between the vent frame and the silver decorative trim on the face of the dash. See photo.



2. Place the ProClip in your hand so the ProClip label (sticker) is at the top.

Press the lower edge of the mount into the seam next to the gap opener.



3. Flex the top of the mount down and hook the top edge under the top edge of the vent frame.

NOTE - The adhesive tape cover should be removed. The tape does not leave any marks or damage the dashboard, and is easy to remove.



4. The ProClip is in place.

The mount will install along both the left and right vents but not over the hazard button.

## Returns

All returns must be made within thirty (30) days of the delivery date and include proof of purchase, a copy of your original order, or invoice. No products shipped hereunder may be returned without ProClip USA's prior approval. In order to return a product, the buyer must obtain an RMA number (Return Merchandise Authorization Number). **Items returned without a valid RMA number may be rejected.
