Carefully read all instructions and review the images before installing this product.



1. Place tablet face up on the Tough Sleeve back plate and connect the power cord. Fit the Tough Sleeve face plate over the tablet to enclose the device. Making sure to hold the sleeve together flip it over and secure using the enclosed screws. Once in place the tablet will be secured inside the Tough Sleeve.



2. Unscrew the screw in the center of the power block so you can remove the tilt swivel base plate on the back. Place the tilt swivel base plate on the mounting surface. Attach the base plate by using the applicable screws enclosed. Place the power block onto the tilt swivel base plate and reattach it with the center screw. Adjust the power block to the preferred position, and then tighten the center screw until the holder has no movement when docking the sleeve.



3. To insert the tablet into the power block slide the block connector into the power block. (contacts should line up) Press key lock to secure.

To remove the sleeve: Undo the lock with the enclosed key. Press the release tab on the power block and slide the sleeve up and away from the charging block and move clip base. The charging connectors in the power block allow the tablet to stay charged while also allowing the sleeve to be easily removed from the mounting location.



4. The sleeve is in place and can be rotated for both landscape and portrait orientation.

## Returns
