1. To attach the pedestal:

Find a good mounting position on your dashboard. Make sure you can get access from behind (to attach the backing plate) by removing the necessary dash panels. Ensure there are no wires behind the mounting spot.

Using the pedestal as a template mark the holes on the dash, or dash panel as shown in picture. Then drill the holes large enough for M4 screws to go through.

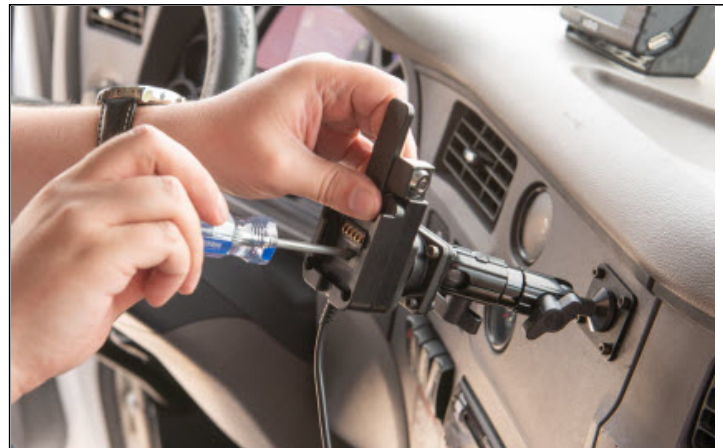


2. Line up the pedestal and the backing plate with the drilled holes. Secure in place using the enclosed screws and locking nuts.



3. To mount the Tough Sleeve:

Undo the center screw in the Quick Release Power Dock. Remove the Tilt-Swivel Base Plate from the dock and attach it to the pedestal face plate using the enclosed screws.



4. Re-attach the dock using the center screw. Tighten semi firmly and adjust the dock to the desired viewing position facing the driver. Then tighten the center screw firmly to lock the position.

Turn over to continue ---->



5. To secure tablet in the sleeve:

Place tablet face up on the Tough Sleeve back plate and connect the power cord. Fit the Tough Sleeve face plate over the tablet to enclose the device. Making sure to hold the sleeve together, flip it over and secure using the enclosed screws. Once in place the tablet will be secured inside the Tough Sleeve.



6. To mount the Quick Release Power Dock:

Unscrew the screw in the center of the power block so you can remove the tilt-swivel base plate on the back. Place the base plate on the mounting surface. Attach the base plate to a wall or any AMPS compatible mount. Replace the power dock with the center screw. Adjust the dock to the preferred position, and then tighten the center screw firmly to lock it into position.



7. To insert the Tough Sleeve:

Insert the Tough Sleeve into the power dock. The release lever will click when the dock is in place. Press the center pin engage the lock.

To remove the sleeve:

Turn the key until the center pin pops out. Press the release tab on the power dock slightly and slide the Tough Sleeve up and out of the dock.



8. Charging while Docked

The charging connectors in the Quick Release Power Dock allow the tablet to stay charged while in the sleeve. This provides the tablet protection while charging and an easy way to remove it for those use cases outside the vehicle.
