



Step 1:

Postion L-Mount (Item1) in desired location on staionary location. Push U-Bolts (Item 2) through L-Mount (Item 1).

STEP 2:

Line the bracket up on the mounting surface and tighten U-Bolts (Item 2) with four (4) Flat Washer (Item 3) and four (4) Hex Nuts to (Item 4). Start with the bottom U-Bolt to get the alignment correct.

STEP 3:

Make sure mount is secure before mounting antenna.
